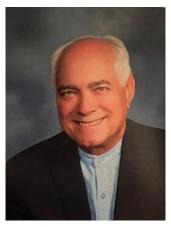

Dear St. Peter's Family,

During this particular season of the church calendar, I am happy to report on the past year of mission and ministry. We find ourselves in the season of Epiphany when we are keenly aware of the ways in which God is made *manifest* to us. In the past year, we came to know Christ among us. We also made him known to others. This is our ongoing mission at St. Peter's, and I would like to report on a number of highlights from the past year in which we met our mission.

You will remember that we began the year identifying five strategic priorities for our mission and ministry:

Worship: St. Peter's offers parishioners and the community a variety of opportunities to glorify God in the Episcopal tradition through inviting liturgy and music.

Invite, Welcome, Connect: St. Peter's invites people to all special events, fellowship and worship. Our newcomer welcoming integration process is in place to help newcomers be fully welcomed, want to come back and have opportunity to connect with programs, ministries, formation and service. We revisit members who aren't attending to encourage them to come back.

Christian Formation and Fellowship: St. Peter's wants to make Disciples in the way of love by raising leaders and coordinating programs to enrich Spiritual Growth. We host small group bible studies, sharing faith dinners and book studies on a regular basis within the Church and the community.

Care for Each Other: St. Peter's provides comprehensive care and ministry by which the pastoral needs of our members and their families are identified and addressed by parishioners and clergy.

Outreach: St. Peter's is actively engaged in ministry and outreach. Through mission trips, community service days and partnerships with charitable organizations, we strive to lift up those struggling and in need so that they may find hope and spiritual renewal through Christ.

The strategic priorities can also be described as "vision areas" for our ministry. You and I were able to see the Lord at work in the past year. It would be difficult to cover it all, and yet the following highlights allow us to see the good work accomplished in these areas where we have dedicated our lives and resources to the glory of God.

- We celebrated Epiphany with the Festival of Lights and the Blessing of the Chalk.
- We started a new Wednesday evening Bible Study called The Parable Club led by Karen Kilgore and Betty Mosty.
- In the spring, Fr. Mike and I taught the Sunday Morning Adult Formation Class titled *Celebrating the Saints*.
- The Labyrinth Guild hosted walks on the Spring Equinox (March 20), World Labyrinth Day (May 7), International Day of Peace (Sept 21), and the Winter Solstice (Dec 21).

- Early in the calendar year, I finished teaching an Adult Confirmation Class that began in the fall of 2021. Also, with assistance from Brian Blacklock, I prepared a group of youth for Confirmation. Eighteen parishioners were subsequently confirmed (or received) by Bishop Reed on Feb. 20.
- We hosted our first Party with a Purpose to support Love for the Least and raised \$9,100. Due to our generous response, we were able to fully fund the Raha House in 2022. The Raha House is a safe house for women who are being trafficked in Kurdistan.
- We hosted a Lent Madness Bracket Party in Tucker Hall on Feb. 23.
- Brian Blacklock, Abby Blacklock, Barbara Jansen, Susan Parker, Jennifer Timko, and I taught an Early Communion Class during Lent and the fourteen children who fully participated in the class received special recognition at the Parish Picnic on April 24.
- The Men of the Church and other volunteers hosted the annual Pancake Supper on March 1 and all
 monetary donations from the supper went to feed refugees at the UN Camp Barnabas, compliments of
 our Diocesan Missionaries and Love for the Least.
- We hosted our annual Lenten Series with the ECW organizing the Soup Suppers. The theme was Following in *the Way of Forgiveness*, and we welcomed another great slate of speakers: the Rev. Chip Prehn, the Rev. Ann Fraser, the Rev. Dr. Steve Bishop, the Rev. Dr. Mike Marsh, and the Rev. Dr. Katherine Lehman.
- I led a Lenten Zoom book study on *In God's Hands* by Desmond Tutu.
- We celebrated Camp Sunday on Feb. 13 welcoming our guest speaker Mrs. Sarah Kates.
- We held the Parish Picnic at Camp Mystic on April 24 with baptisms in the Guadalupe River and a wonderful all-parish lunch.
- The McCaskill Scholarship Committee awarded \$10,000 in scholarship monies to St. Peter's School Families. Additional monies from the McCaskill Scholarship Fund were designated for diocesan camp scholarships and St. Peter's School tuition assistance for St. Peter's Episcopal Church staff.
- In the Spring, we completed three service projects on Wednesday nights. Our most significant project was putting together backpacks filled with nonperishable meals for underprivileged families in KISD.
- On April 20, members of the Labyrinth Guild and I toured the TMI Campus, hosted by the Rev. Dr. Ben Nelson, the Chaplain at TMI. The highlight of the tour was seeing the Labyrinth on the TMI campus.
- In the spring, we said goodbye to Brian Blacklock and his family. We sent them off with a "Super Sundae Sendoff" and a Wednesday Tacos and Talent Night. We will remain grateful for Brian's ministry among us and wish him well in his pursuits to be a full-time seminary student. The entire Blacklock family were such a blessing to our parish during their time in Kerrville.
- On May 12, the Peterson Hospice Memorial Service was held at St. Peter's, and I was honored to preach at the service.
- On May 13, we hosted a parish-wide dinner in Tucker Hall to celebrate the milestone of more than doubling our Rock of St. Peter's Endowment Fund in the span of three years.
- On May 29, we welcomed the Rev. Canon John L. Peterson to preach. Canon Peterson is the former Secretary General of the Worldwide Communion. Prior to his appointment as Secretary General, Canon Peterson was Dean of St. George's College, Jerusalem. Canon Peterson preached at St. Peter's the Sunday before a group from the parish went on a pilgrimage to the Holy Land.
- In early June, Fr. Mike and I led a group of thirty-five pilgrims to the Holy Land. You can watch the highlight reel of our pilgrimage at this link. We can be grateful to the Rev. Canon Ann Normand who served as the chaplain at St. Peter's while we were away on pilgrimage. The parish was in very good hands with Rev. Ann!
- In June, I was glad to welcome Jenny Ligon to our staff to serve as the Children's Minister at St. Peter's.

- In July, under the leadership of Jenny Ligon, we hosted Zoomerang Vacation Bible School for more than one hundred eighty (180) children in our community! You can watch the highlight reel at this link.
- In August, our group of Holy Land pilgrims made two presentations to the entire parish.
- We had a great turnout at church on Sunday, August 14 for the Blessing of the Backpacks.
- In late August, we welcomed Jerry and Stacy to St. Peter's. The two of them shared with us about their amazing ministry, and Fr. Jerry preached at St. Peter's on Sunday, August 28. We continue to grow in our support and partnership with Love for the Least.
- We had a wonderful Rally Day on Sunday, September 11. The day was full of love, smiles, and sunshine. You can find the highlight reel at this link.
- In the fall, Fr. Mike and I led a class on Sunday mornings titled *The New Testament You Never Knew*.
- At several Vestry meetings, we discussed the ministry of the Compass Rose Society. Vestry Member Bob Kinnan attended an informational dinner in San Antonio to be introduced to the Society. He subsequently attended the Society's Annual Meeting in London. Bob voiced his endorsement of the Society. We also welcomed a Board Member, the Rev. Bill Fowler, to a Vestry meeting where he spoke to the ministry of Compass Rose. The Vestry made budgetary plans to join the Compass Rose Society in 2023.
- We held the Blessing of the Animals at St. Peter's on Sunday, October 2, and collected donations for Kerrville Pets Alive.
- In September, I was glad to welcome Kelsey Keller and Kourtney Doster to our staff. Kelsey was hired to serve as the High School Youth Minister and Kourtney was hired to serves as our Middle School Youth Minister.
- In September, Jenny Ligon and I took a group from the parish to Mustang Island Conference Center for St, Peter's Family Camp. Thirty-five of us from the parish went to Port Aransas to enjoy our diocesan conference center on the beach. It was a life-giving weekend full of worship, teaching, fellowship, and fun in the sun!
- In September and October, I led a Newcomers Class for more than thirty new members of the parish.
- Following the Newcomers Class, I taught an Adult Confirmation and Inquirers Class with twenty-seven in the class. Most of the people in that class will be presented for Confirmation, Reception, or Reaffirmation when the bishop visits on February 5, 2023.
- On October 2, we celebrated Episcopal School Sunday hearing from one of our former students, Grace MacDonald. We also invited parishioners to take Bible Bookmarks with the name of a student on each bookmark, so they might pray for the students by name.
- Under the leadership of Hiram Wilson, we had a successful Generosity Campaign based on the theme *Transformed by Grace, Faith, and Love*. We heard testimonials from a couple of parishioners: Grant Baehre and Mari Glamser-Samuel. The campaign culminated with Generosity Sunday on November 13. On that day, the Rev. Dr. Ben Nelson preached a compelling sermon, and Hiram and his team hosted a *fabulous* reception in Tucker Hall. With our Generosity Commission, we are always hoping to see parishioners take the step in their giving in order to grow spiritually in their generosity. We saw a number of parishioners increase in their giving and several first-time givers. Generosity is at the heart of our God. Our goal is to become more like the God in whose image we are made!
- In the fall, thanks to the work of the Christian Formation Goal Team, we offered a new class on Sundays for parents: The Gifts of Imperfect Parenting based on the work and research of Dr. Brené Brown.
- In the late fall, Anne King responded to the call for a new Labyrinth Guild Coordinator. Anne will eventually be trained and work with Cindy Bachman in the transition.

- On Veterans Day, we hosted a special service to honor veterans, followed by a reception in Tucker Hall. Lieutenant General Mike Oates was the guest speaker at the service, and we had a WWII veteran present at the service. We had a very good turnout for the service and more than half of the people in attendance were from the greater community. We took up an offering to directly support the Together With Veterans (TWV) program which seeks to reduce Veteran suicide in our community. We were proud to hold the Veterans Day Service and reception for the benefit of the greater community, especially with our high population of veterans in Kerr County.
- In the late fall, our St. Paul's Guild grew in membership thanks to the training provided by Fr. Mike.
- In the late fall and Advent, we provided several Advent programs for families: the Advent Wreath-Making Event, the St. Nicholas Visit, a Birthday Party of Jesus, and the Santa Claus party.
- In Advent, Fr. Mike and I led a Sunday morning study of the Advent Collects (prayers). We "unpacked" those treasured prayers to go deeper into the holy season of Advent.
- In Advent, we welcomed the Rev. Dr. Mike Marsh to be our Advent Quiet Day teacher and preacher. With his teachings, Fr. Mike Marsh used a number of icons to guide the class through a series of rich meditations.
- On December 6, we partnered with four other downtown churches for the annual Downtown Christmas Walk. We welcomed the Rev. Bill Crain to be guest preacher at St. Peter's, and I was honored to be the guest preacher at First Presbyterian.
- On December 11, we hosted the annual Children's Christmas Pageant in Tucker Hall. We had a great turnout of families with a number of children taking part in the service. Also, children from the church and school sang at the offertory: *Peace like a river*.
- On December 15, I was happy to co-present a book review with Dr. Michael Attas. The two of us had a friendly and lively conversation about his book *Fly-Fishing: the Sacred Art*.
- On December 18, we hosted a lovely service of Lessons and Carols. I am grateful to Fr. Mike and the readers for their preparation to read the lessons. I am also grateful to David Miron, Claire Rabson, and the chancel choir for their *beautiful* singing and ministry of music.
- In addition to my local responsibilities within the parish, I remain involved in several ministries outside
 of the parish: Camp Capers Master Planning Committee; Sewanee Intern Program, DWTX Liaison; TMI
 Episcopal School Board, Trustee; DWTX Clergy Continuing Education Committee, Co-Chair; DWTX
 Examining Chaplains; DWTX New Clergy Formation Program, Co-Facilitator; Seminary of the Southwest
 Board, Trustee.

The past year was another fruitful year of mission and ministry, and more people are involved in the work of the church. We increased the membership on the goal teams for each area of ministry. I am grateful for our shared ministry and the ways in which the Lord is leading us into a promising future. The year ahead will be another full year in which we will know Christ and make him known to others. Thanks be to God!

Last year has been an exciting year for St. Peter's. As Covid has started loosening its grip on us, it has been exciting to see our parishioners start coming back to inperson worship.

St. Peter's School continues to excel. The school continues to be at capacity with a waiting list. After doing grant research, Janet was able to obtain a grant of \$494K. This money will go increase teacher pay, bonuses, benefits, and help with student scholarships.

In April of 2022, a building and grounds commission was formed. It will be exciting to see what this talented group of individuals will come up with to enhance our campus. Our first of two projects will focus on beautifying the current columbarium

and adding a new columbarium in a different location. The second project is going to beautify our parlor by adding stained glass windows and doors going into the Nave. Look forward to hearing more about this in 2023!

There were many improvements and repairs to the St. Peter's Church over 2022:

- 1. Two A/C Units in the Cottage Shop were replaced.
- 2. The Youth Room Floor was renovated with a floating floor.
- 3. Several loose tiles in Shelton Hall were replaced.
- 4. The window frames to the Parlor were repaired and repainted.
- 5. Wall pack lighting outside Tucker Hall was replaced
- 6. Exterior door near the chapel was replaced with a more secure door.
- 7. Rolling Partitions for Tucker Hall were ordered in order to have the ability for different groups to be able to use the space at the same time.
- 8. A New Chinquapin Oak Tree was replanted for a tree we had lost to the big freeze 2 years prior.
- 9. The Video & Sound Booth was moved to a different location in the Sanctuary to make way for the choir improvements.
- 10. Closers were added to some doors at the school that were missing some.
- 11. Repairs to the floor and walls in a teacher's lounge bathroom due to water damage.

ORGAN REPORT

Submitted by David Miron, Director of Music/Organist

In late 2021 the organ committee and I met and agreed to revise the scope of the project to make completion of this phase more possible. Following this, these are the portions that were completed in 2022:

- Revised the façade design, which were approved by organ committee; recruited artist friend to design ornamental pipe shades for above tops of pipes in façade (previous installation did not have these, they are traditional in organ design)
- Replacement keyboards were restored, modified for optical control systems, optical controls were installed, and combination pistons wired: keyboards are ready to install in 2023
- Many small parts were made: wiring junction strips, windchest parts, pipe racking; main Great division windchest was repaired and made ready for connection in 2023
- New control system design was finalized and components ordered; console was prepared for new system to be installed in 2023
- Six new offset chests were made to hold 2 sets of pipes from the 'free organ' (8' Hautbois and 16' Basson stops, which are new to our organ)
- Rack boards on main Swell chests were modified for 2 stops to be changed, for better tonal balance (Mixture 3 ranks, and Vox Humana, formerly in Choir division)
- Wind system was redesigned (for the third and final time) and new parts made and installed to reduce blower noise (noise reduced by 40%)
- Structures and supports for new offset chests and walk boards were built and installed; Walk board and ladder in Swell division made and installed

- All new offset chests were internally, and to junction strips; will be wired to output boards by February 2023 so these stops can be tuned and then used in worship
- New reed pipes from 'free organ' rebuilt: pipes disassembled, reeds and shallots cleaned an polished, resonators washed, new wedges made, pipes reassembled; repairs to some existing flue pipes; many small pipes regulated and some tonal adjustments
- Transept façade chests built, and part of structure: these will be installed prior to Holy Week this year

I met with the organ committee early January and gave a work schedule; I will be doing weekly updates to them on progress. I estimate 90% of the work is complete on this phase, and I will have this phase done by the end of May.

- 1. Complete Swell wiring: week of Jan 9
- 2. Put remaining pipes in Swell: week of Jan 16
- 3. Program Swell stops
- 4. Install Swell shade frame: week of Jan 16
- 5. Build swell box wall: remainder of January
- 6. Install Transept façade: 1st half of February
- 7. Install Great and Pedal reservoirs: week of February 13
- 8. Connect Great and pedal windchests to wind: week of February 13
- Complete altar façade chests: Remainder of February and week of March 6
- 10. Complete and install altar façade: Remainder of March

Holy Week and Easter

- 11. Wind all façade chests: week of April 11
- 12. Wire façade chests: week of April 17
- 13. Rebuild stop rail: remainder of April
- 14. Install keyboards and new stop rail: May
- Install new computer in console and reprogram:May
- 16. Rewire Balcony: May

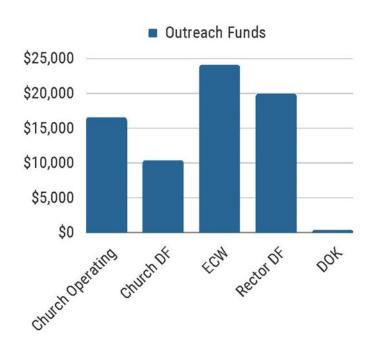

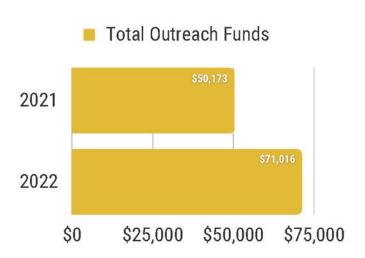

The Cottage Shop has been in operation for 55 years. There are 40 ladies involved in the daily operations and 4 of these are not Episcopalians. This is truly a testament to the loving people of our community who have given so graciously over the years. In addition to all our volunteers, many of our ECW ladies have given their time and talents. To each of these individuals we offer our gratitude, for they have made The Cottage Shop a place of love and joy. We have sadly said goodbye to several of our faithful and longtime volunteers this year as some moved away, some to heaven, and some retired due to poor health. We have had the joy of welcoming several new and returning volunteers to our circle of friends.

A new brochure was created for The Cottage Shop, and we would like to thank Lauren Vereen, Communications Coordinator for helping us with this project. The ECW gave a lovely "Appreciation Luncheon" for all Cottage Shop volunteers in November.

We had an excellent, successful, and record-breaking year in 2022 achieving the "Best Ever" total gross sales of \$117,754.39. We continue to be open 3 days each week, Tuesdays, Thursdays, and Fridays. Each of these days has a morning and afternoon sales team. Mondays continue to be a workday, pricing merchandise, setting up the shop for the coming week, receiving all donations and consignments by appointment only.

Every month in 2022 except for October set records over the same month in 2021. December had the "Best Ever Month" gross sales, in the amount of \$14,461.47. A new credit card sales record was set December 6th in the amount \$1,034.64.

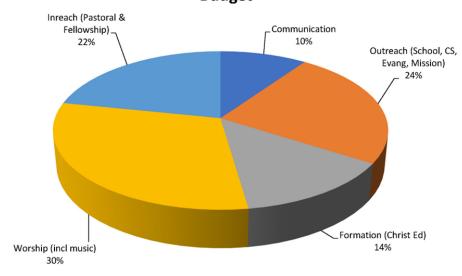
